Club's that are affiliated with other Clubs as part of a chain or other group may register and take part in the Challenge only as individual Clubs; not as part of the group. To be eligible each Club must register separately. Only the person designated as the "Facility Director" for the Club may register the Club to participate in the Challenge.

Members: In order to participate in the Challenge on behalf of a Club registered to participate in the Challenge (participating Clubs will listed at "club finder" at the www.technogym.com/us/letsmove website), the Club must first confirm that the participant is an enrolled member of the Club and:

- is a legal resident of the United States, and
- is at least 18 years of age or, if under 18, the Club must have obtained written consent from the participant's parent(s) or guardian(s) and
- have the participant sign or agree in writing to the terms of the Participant Consent.

Once the Club has confirmed the participant is eligible to participate in the Challenge, the participant must sign-up activating the Challenge function and selecting "Let's Move for a Better World" from either a Machine at the Club connected to the mywellness Platform or by entering a mywellness key into one of the Club's mywellness Cloud kiosks. In order for the participant's MOVEs to be counted toward the Club's total, the participant must train on one of the Club Machines using the Club's Challenge App.

Prize Recipients: A Prize Recipient must meet the below requirements to be eligible to receive a Prize. In addition, as a condition to being awarded the Prize, the Prize Recipient designated by the Prize Winner must complete, sign and deliver the **School Prize Acceptance Affidavit and Release Form** (or similar release for the Qualified Charity) to the Prize Winner. MOVES RANKING

The collection of MOVEs for each participating Club will be displayed through a "MOVEs counter" on the technogym.com/letsmove website, which will provide an update in real time of the MOVEs accumulated by the participating Clubs in the United States. The MOVEs total on the Technogym website will be identified by type and number by Club, but not by the identity of the members performing them. The total number of MOVEs for each Club will be displayed and will include only the first names of the members listed and their MOVEs.

In addition to the total number of MOVEs for each Club, the technogym.com/us/letsmove website will display the total number of registered participants participating in the Challenge with the number of MOVEs for each and a "CLUB RANKING": The total number of MOVEs collected by each Club will be displayed. MOVEs collected from activities outside the Club or manually uploaded will not be counted toward a Club's total MOVEs. The ranking of the Clubs will be determined by the total number of MOVEs by registered participants of the Club.

WINNER SELECTION

The Club in the United States with the most total MOVEs at 12:00 a.m. EST on March 22, 2015 at (the "Selection Date") will be selected as the Winner of the Challenge and next two Clubs with the highest number of MOVEs over 1,000,000 will be selected as first and second Runner-Up (the Club with the largest number of MOVEs after the Winner will be the first Runner-Up). The sole determinant of the time for the purpose of determining the Challenge Winner will be the time stamp recorded on Technogym Machines registered for the Challenge. In the event of a tie, the Club with the most members participating in the Challenge (among the tied Clubs) shall be the Winner and the same process shall be used to determine the Runners-Up in the event of a tie. The Charity meets the eligibility requirements for the Challenge as described in the Official Rules; the Charity agrees to all of the terms of the Official Rules; the Charity is legally permitted to redeem and accept the Prize awarded by Technogym and has agreed to do so; the Charity has authorized me to sign this Release for and on its behalf, with the intention that it shall be bound by the terms set forth herein. 3. Assistance.

(b) **Participant Consent.** No Charity personnel may participate in the Prize award ceremony (e.g., by appearing, speaking, performing, or presenting during and as part of the Prize award ceremony) or demonstrate or utilize in any way the Technogym® Excite + exercise equipment during and as part of the Prize award ceremony without executing a Release and Consent Form (as provided by Technogym). The Charity acknowledges and agrees that the Prize will not be delivered to the Charity and no Charity personnel may participate in the Prize award ceremony unless the Charity and all Charity personnel participating in the Prize award ceremony have signed and delivered to the Charity a signed Release and Consent Form. The Charity covenants and agrees to obtain a signed Release Form from the Charity and each participant and to deliver the Release Form to Technogym at 700 US Highway 46 East, Fairfield, NJ 07004 by no later than five (5) days prior to the Prize award ceremony.

4. Permissions.

- (a) <u>Use of the Charity's Name and Image</u>. The Charity hereby grants to Technogym Parties the absolute right and permission to (i) use, publish, broadcast, and copyright the Charity's name and images of the Charity (photographic and videotaped), or to refrain from so doing, in any manner or media whatsoever for purposes of advertising or trade in promoting and publicizing Technogym's business, products, services, or the Challenge; and (ii) to photograph and/or videotape the Prize award ceremony for use in promoting Technogym's business, products, services, or the Challenge and to copyright and/or use and/or publish the same for such purpose or any other purpose throughout the world. The Charity agrees that the Technogym Parties may exercise all of the above rights without notice and without further compensation and that neither I nor the Charity shall have any right of approval, or claim (including without limitation, claims based upon invasion of privacy, defamation, or right of publicity) arising out of any use, alteration, distortion, or illusionary effect or use of any of the above in any composite form.
- (b) <u>License</u>. The Charity hereby grants to Technogym and all Technogym Parties the perpetual, royalty-free, irrevocable, worldwide right and license to use, publish, broadcast, and copyright the Charity's voice recording, name, picture, and likeness, or to refrain from so doing, in any manner or media whatsoever for its business and commercial purposes including, without limitation, promoting and advertising the Challenge, Technogym, or any other use Technogym decides to make. I agree that the Technogym Parties may exercise all of the above rights without notice to me or the Charity and without further compensation and that neither I nor the Charity shall have any right of approval, or claim (including without limitation, claims based upon invasion of privacy, defamation or right of publicity) arising out of any use, alteration, distortion or illusionary effect or use of any of the above in any composite form.
- (c) <u>Ownership</u>. The Charity agrees that any video recording, picture, or likeness of the Charity or anything derived therefrom created by the Technogym Parties is owned by them. If the Charity or the Charity's personnel should receive any print, negative or other copy, they shall not authorize its use by anyone else.
- **Taxes.** The Charity covenants and agrees to be responsible for the payment of any transfer, sales, use, stamp, conveyance, value added, documentary, filing, federal, provincial, state, and local

taxes and any other costs and administrative fees (collectively, the "**Taxes**") not specifically stated in this Release Form (or the Acknowledgment Email) related to or caused by being designated the recipient of the Prize award and Technogym may issue an IRS Form 1099 for the total Estimated Retail Value of any Prize. Please visit the Official Rules for the Estimated Retail Value of the Prize.

6. Release of Liability/Assumption of Risk and Waiver.

- (a) <u>Participation</u>. The Charity acknowledges and agrees that its acceptance, redemption and use of, and participation in the Prize or any part of it, are all undertaken voluntarily and entirely at its own risk and the Charity agrees to assume all such risk, including risk of property damage, bodily injury or death, and all other damage or potential damage, whether known or unknown to the Charity.
- (b) Release. The Charity agrees to release Technogym, all Technogym Parties, and their subsidiaries, affiliates, divisions, employees, officers, directors, advertising and promotion, fulfillment and/or judging agencies, and related entities (together, the "Released Parties") from any and all claims, causes, suits, or other liability for any loss, harm, damages, costs, or expenses, whether known or unknown to the Charity, including without limitation property damages, personal injury, and/or death arising out of the acceptance, possession, redemption, use or misuse of, and participation in any Prize or any part of it as well as any claims based on publicity rights, defamation, or invasion of privacy and merchandise delivery, including, without limitation, any such claims alleging or arising as the result of Released Parties' negligence (together, "Claims").
- (c) <u>Waiver</u>. The Charity agrees to forever waive any and all Claims against the Released Parties and acknowledges and agrees that the foregoing waiver and release shall be binding on the Charity's heirs, estate, successors, and assigns. **FOR RESIDENTS OF THE STATE OF CALIFORNIA**: the Charity acknowledges and agrees that its release and waiver extends to the following, the protections of which the Charity explicitly waives:

California Civil Code Section 1542: A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor.

- (d) <u>Dispute</u>. The Charity hereby waives any right it may have to dispute the scope of this Release Form on the grounds that it is a general release and a release of unknown Claims.
- 7. Indemnity. The Charity further agrees to indemnify, defend, and hold harmless the Released Parties from and against all loss or damage arising from Claims and from any failure of the Charity to comply with or perform any obligation or undertaking under the Official Rules or this Release Form, including without limitation any Claim arising out of or relating to the Charity's failure to obtain the required consents and releases from participants, and the Charity's acceptance, use (or misuse), and redemption of the Prize and the Charity's participation in it and/or any part of it.
- 8. Specific Acknowledgment. THE CHARITY SPECIFICALLY UNDERSTANDS AND AGREES THAT THE FOREGOING RELEASE AND INDEMNITY WILL PREVENT THE CHARITY AND ITS SUCCESSORS FROM BRINGING A LAWSUIT, CLAIM OR OTHER ACTION AGAINST TECHNOGYM OR ANY OTHER RELEASED PARTY AND FROM RECOVERING ANY MONEY DAMAGES OR OTHER LEGAL RELIEF FROM TECHNOGYM OR ANY OTHER RELEASED PARTY IN CONNECTION WITH ANY OF THE CLAIMS RELEASED ABOVE.

- **9. No Warranties.** The Charity hereby agrees that Technogym has neither made nor is in any manner responsible or liable for any warranty, representation, or guarantee, expressed or implied, in fact or in law, relative to the Prize, including but not limited to its quality, merchantability, fitness for a particular purpose, or mechanical condition.
- **10. Enforceability.** If any provision of this Release Form is found to be unenforceable in any respect by a court, it is the Charity's intention and understanding that this Release Form will nonetheless be enforced to the maximum extent to which it is found by the court to be legally enforceable.
- 11. Entire Agreement. This Release Form (including the Acknowledgment Email and Official Rules incorporated herein) constitutes the entire agreement between Technogym and the Charity with respect to the matters described herein, and supersedes any and all other agreements and communications, oral or written, between any Released Party and the Charity with respect to such matters. This Release Form may not be amended or supplemented except by a writing signed by both Technogym and the Charity specifically referencing it.
- **12. Jurisdiction.** This Release Form is governed by the laws of the state of New York, which shall apply exclusively to the Challenge and all matters subject to this Release Form without regard to its conflicts of laws principles, and any dispute with respect thereto shall be resolved in either the federal or state courts located in New York City. The Charity consents to the exclusive jurisdiction of the courts of competent jurisdiction located in New York City for any disputes arising out of or relating to this Release Form and/or any disputes the Charity may have with Technogym arising out of or relating to the Charity's acceptance, use and redemption of, and participation in, the Prize or any part of it.
- **13. Material Inducement.** The Charity acknowledges and agrees that its agreement to the terms set forth above is material inducement for Technogym to provide a Prize to the Charity and that Technogym would not do so in the absence of the Charity's agreement.
- **14. All Information True and Correct.** I declare that all information the Charity submits in this Release Form is true and correct.
